Information on the processing of personal data in connection with the Implementation of the Measles Protection Act

**Responsibility** for the processing of data in connection with the Act for Protection against Measles (Measles Protection Act) lies with the school.

**Purposes and legal basis for processing your data:** The school processes data for the purpose of implementing the Measles Protection Act. The school has to check the evidence whether pupils, teachers and other persons working at the school have sufficient vaccination protection against measles, have immunity against measles or cannot be vaccinated against measles due to a medical contraindication. Proof of sufficient measles protection is documented to the required extent (fulfilment or non-fulfilment of the requirements of § 20 Para. 9 and Para. 10 of the Infection Protection Act - IfSG and justification for this) in a template. This will be stored in the pupil/health file. For teachers and staff members, it is stored in the staff file. The documents submitted to the school for proof are only necessary for the examination of the requirements and are not stored after the template has been completed. (Legal basis: § 2 number 16, § 20 paragraphs 8 to 10, 13 Infection Protection Act)

**Recipients of personal data:** The data will be passed on to the following authorities if the relevant requirements are met:

- If applicable, the responsible public health authority in the case of insufficient or no proof (see above; § 20 Para. 8-10 IfSG).
- if applicable, the responsible school supervisory authorities (Art. 113 BayEUG)
- Host school in the case of a change of school (§ 39 BaySchO)

**Duration of storage of personal data:** Data will be kept in accordance with the school's privacy statement.
