Internship outside Munich

Dear Parents,

Your son/daughter has decided to complete his/her work placement outside Munich. The work placement will take place from Monday, 26.06.2023, to Friday, 07.07.2023. In principle, the school's insurance also covers internships; however, the prerequisite is that the internship is internally connected to the school attendance and can also be assigned to the school's organisational area of responsibility. Particularly in the case of an internship abroad, the school is not in a position to guarantee such comprehensive internship support due to the large geographical distance. This means that you should make your own arrangements for travel, accommodation, supervision both at the placement site and for the time your child spends away from the placement site, and ensure that your child is properly insured for the duration of the work placement. We therefore recommend that you contact your personal insurance company about this. You should also check the cover provided by your health insurance. We assume that the cost of additional insurance is low, but it should still be taken out if necessary.

As confirmation that you have taken note of this regulation, please complete the form below and return it to your careers councilor by 08 May 2023.

Important: Students who have not submitted this confirmation by this date are not eligible to complete their internship away from Munich!
